APPLICANT DECLARATION FORM

To: British Columbia Hydro and Power Authority (“**BC Hydro**”)

Re: BC Hydro 2026 Call for Demand for Emerging Industries (“**CFD**”)

The Applicant declares, represents and confirms:

Nature of the Project

- (a) that the Project covered in its Application is not for electricity for a “*new low-voltage cryptocurrency project*” nor a “*new high-voltage cryptocurrency project*” each as defined in the *Cryptocurrency Power Regulation*, B.C. Reg. 163/2024 and that the Applicant does not intend to operate such aforementioned cryptocurrency projects, whether within the Project or otherwise, that would take service from BC Hydro through the interconnection point for the Project to BC Hydro’s System;
- (b) that the Project covered in its Application is for use of electricity in or for “*A.I. data centre purposes*” or “*conventional data centre purposes*” as defined in the *Data Centre Facility and Hydrogen Production Facility Power Supply Regulation*.
- (c) that BC Hydro has the right to verify and confirm the statements at paragraphs (a) and (b) above at any time and in any manner that it determines is necessary, including without limitation the: (i) the right to physical inspection of the facility covered by the Project upon reasonable notice, as applicable, (ii) by requiring the Applicant to provide further supporting documentation or information under the CFD process or otherwise; and (iii) by requiring a statutory declaration or other instrument signed by a director, officer or other authorized representative of the Applicant in a form that is acceptable to BC Hydro;

Other CFD Matters

- (d) it received, has examined and understands the CFD, including all Schedules and any issued Addenda;
- (e) it agrees to all terms and conditions of the CFD and has complied with the CFD;
- (f) it completed in full this Initial Application and provided all necessary and relevant details in this Initial Application and will do the same in respect of its Supplemental Application, if any;
- (g) it prepared this Initial Application, and will prepare its Supplemental Application, if any, with the genuine bona fide purpose of being selected by BC Hydro, without collusion or fraud

and in fair competition with other Applicants, and affirms the representations set out in the CFD;

- (h) it made all relevant disclosures requested in the CFD; and
- (i) it provided statements and information in this Initial Application, and will provide statements and information in its Supplemental Application, if any, that are true and accurate, and this Initial Application does not, and its Supplemental Application, if any, will not, contain any false or misleading statements or information.
