**INSTRUCTIONS**

Words and phrases used in this document and defined in the CFD have the meanings given in the CFD. To complete the Supplemental Application on the next page, please follow the instructions below:

1. Insert date of submission at the top where there is currently a blank line.
2. Insert the Project name in the Re: line where there is currently a blank line.
  - **Note:** The Project name should be the same as the Project name specified in the corresponding Initial Application.
3. Insert a bid price in paragraph (b)(i) where there is currently a blank line.
  - **Note:** Where an Applicant elects to submit the same bid price percentage that was submitted as part of the Initial Application, then the Applicant should insert the words “***Not Applicable***” in the blank line.
4. Insert new proposed curtailment commitment in Appendix 1 which is currently blank.
  - **Note:** Where an Applicant elects to submit the same curtailment commitment that was submitted as part of the Initial Application, then the Applicant should insert the words “***Not Applicable***” in Appendix 1.
  - If the Applicant elects to submit a curtailment proposal that is different than what was submitted as part of the Initial Application, the Applicant must:
    - continue to meet the minimum requirements for curtailment as specified in Schedule 3, **OR**
    - meet the minimum requirements in all curtailment characteristics as specified in Schedule 3 except those where they elect to exceed a minimum requirement for a particular characteristic for curtailment.

For clarity, exceeding the minimum requirements can be elected in all or one of the following manners:

- percent of the electricity or load requested in the Application;
- consecutive hours of curtailment in a day;
- days of curtailment events per calendar week;
- weeks in which curtailment events occur per calendar month;
- number of curtailment events per 12-month period commencing October 1 and ending September 30; and

- number of hours of curtailment per 12-month period commencing October 1 and ending September 30.
5. Insert Applicant name after “Yours Truly” where there is currently a blank line.
- **Note:** The Applicant should be the same Applicant that submitted the corresponding Initial Application.
6. Authorized signatory should sign in the space provided and print name and office in the space provided.
- **Note:** Where an Applicant submitted multiple Initial Applications for different facilities, submit a separate Supplemental Application for each Initial Application that was previously submitted.
