
What you can expect on your bill

As a self-generation customer, the electricity you generate is first used by your home or business. Your net consumption of electricity from BC Hydro is recorded under inflow. When you generate more electricity than you consume, the excess generation is fed back to the grid and shown under outflow.



As a self-generation customer, the total amount of electricity to be charged is your inflow minus your outflow minus the previous balance of generation.

- 1 Electricity inflow is 4,581 kWh
- 2 Electricity outflow is **1,494 kWh**
- 2 Previous balance of generation is **O kWh**
- Total amount of electricity to be charged: 4,581 kWh 1,494 kWh 0 kWh = 3,087 kWh
